Requirements/Eligibility

- **Digital Entry Deadline: August 31, 2024, at midnight.**
- **Juror: Fleming Markel**
- **Exhibition Dates:** Show will be on display from October 5 - November 9, 2024
- **Eligibility:** The competition is open to any artists eighteen years or older currently residing in South Carolina.
- **Digital Entries:** · Up to 2 original artworks may be submitted using the [ONLINE ENTRY FORM](#). **Can send up to 2 images per entry.**
- **Entry Fee: August 1-15: \$20.00; August 16-31: \$30.00.** (This fee covers up to 2 entries.) Payment is required at time of submission (PayPal). No refunds after submission of payment.
- **Eligible Work:** All work must be original and created within the past 5 years. All work must be “exhibition ready.” If works are not adequately prepared for display, they will be ineligible for the exhibition. The Pickens County Museum of Art and History is a public facility we cannot display any works that include nudity, violence, or graphic language/actions. Pickens County Museum staff reserve the right to refuse any submission that it deems unacceptable for the exhibition. These works may be in any 2-D or 3-D media including painting, drawing, photography, fiber, printmaking, illustration, mixed media, sculpture, ceramics, etc.
- **Size Limitations:** Each piece must be under 75 pounds and be able to fit through a standard door 40” wide x 72” length.
- **Commission:** All work will be available for sale with a 20% commission to benefit the Pickens County Museum Foundation.
- **Submission:** Must be in JPEG format, at least 1 MB in size but not to exceed 4. Label each image with your last name/first initial and title (SmithJ_Flowers.jpg).
- **Your entry automatically indicates your agreement to the terms below:**

The Pickens County Museum of Art and History does not assume responsibility for insuring works of art. All artworks will be handled with care. Loss or damage of works while on exhibit, during shipping or transport, or during the installation and deinstallation of the exhibition is not the responsibility of the Pickens County Museum of Art and History. We reserve the right to refuse any entry and to withdraw any work from the exhibition at our discretion. The Pickens County Museum of Art and History reserves the right to photograph and reproduce any entry submitted for educational, informational, or publicity purposes. Submission of an entry in the exhibit will constitute agreement by the artist with all conditions set forth in this prospectus.

- **Notifications:** Acceptance/rejection notifications will be sent via email by September 7, 2024.
- **Accepted Artwork:** · All accepted work must be properly framed, or gallery wrapped (canvas stretched around a stretcher frame to create a clean, professional appearance), and wired for hanging. No exceptions will be made! Failure to present work in this fashion can mean disqualification. Accepted artwork must have the following info attached directly to the artwork:

Artist Name, Address, Phone, Email, Title of the Work, Medium, Year Completed, and Sales Price. Accepted artwork may be hand delivered or shipped.

Hand-delivered work must be dropped off between 9 am and 5 pm September 18-20, or between 10 am and 2 pm on Saturday, September 21 at 307 Johnson St, Pickens, South Carolina, 29671.

- **Artwork Pick-Up:** All artwork, unless shipped or prior arrangements have been made, must be picked up between 9 am and 5 pm on Wednesday, November 13, Thursday, November 14, Friday, November 15, or between 10 am and 2 pm on Saturday, November 16 at 307 Johnson St, Pickens, South Carolina, 29671. **All artwork not picked-up within 30 days will become the property of the Pickens County Museum of Art and History.**
